## **About VTIPG**

Founded in 2006, the Virginia Tech Institute for Policy and Governance is actively involved in empirical and theoretical research, and supports sponsored research endeavors in the College of Liberal Arts and Human Sciences (CLAHS).

We engage in research, capacity building, technical assistance and community-based participatory inquiry with and on behalf of those we serve; principally public, nonprofit and private organizations, and the vulnerable populations and communities those entities support.

Our projects broadly encompass research and praxis in the areas of Urban & Community Development, Health & Human Sciences, Governance & Management, Sustainability & the Environment, and Democracy & Civil Society. We coordinate with academic and community partners across the university, region, nation, and beyond.

Our main office is located in Blacksburg, VA. However, we also have dedicated personnel in Richmond, Abingdon, and Fairfax. The Institute employs faculty, staff, graduate students, and postdoctoral researchers, and collaborates with resident and non-resident research associates and fellows.

# Key Highlights from the Past Year: A Note from the Director



The 2023-24 year has been an eventful one for the Institute and I seek to offer a brief overview here. Here are some highlights, grouped by topic for convenience.

### **Institutional Changes**

The Institute formally became a research center of the College of Liberal
Arts and Human Sciences (CLAHS), transferring from the School of Public
International Affairs (SPIA), on July 1, 2024. We are grateful for the
guidance and support of Dean Laura Belmonte and look forward to working
closely with the Dean and her colleagues as we continue our research and
scholarship.

### **People**

 We were delighted to welcome Megan Notter as our Grant and Fiscal Manager in the Fall of 2023. She has quickly taken our grant and fiscal stewardship to a high level of professionalism as we grew this past year.

- We also formally welcomed five additional research faculty and staff to the Institute on July 1, 2024. The group has been leading cognate research and capacity building efforts from Richmond for that region and the Commonwealth during the past several years. We extend a warm welcome to Cecily Rodriguez, now our Associate Director for Research and Organizational Innovation, Dr. Anne Walters, Dr. Andrew Sharp, Hilal Yalcin, and Ryan O'Connell!
- We were very pleased to welcome five other additions to our faculty:
  - Dr. Kimberly Horn, who previously was affiliated with the Fralin Biomedical Research Institute, joined us as a Research Scientist.
  - Dr. Ciara Collins is our new Family Research Unit (FRU) Director, and we look forward very much to working with her. She brings a wealth of relevant knowledge and a strong research background to her new post.
  - Dr. Bernice Owusu-Brown joins the Institute from service as a Post-Doctoral Associate in the Department of Economics. She brings a strong background in health economics, gender economics, and international development.
  - Dr. Ariel Otruba, faculty member at Arcadia University, and Dr. Vanessa Guerra, Assistant Professor of Urban and Environmental Planning at the University of Virginia School of Architecture, have joined the Institute as Non-Resident Research Associates.

Each of these individuals is outstanding and we look forward to continuing to work with them!

- Andrea Briceno Mosquera has transitioned from her previous role as postdoctoral scholar at VTIPG and is now with the Institute as a Research Scientist. She will continue to work closely with me, David Moore, Mary Beth Dunkenberger, and Cecily Rodriguez.
- Viola Runia recently joined our FRU group as a Court Specialist. She comes to us with significant experience and is already making her mark on her efforts in Fairfax.

- We also congratulate two of our recently completed affiliated doctoral students who have now assumed full-time academic positions:
  - Dr. Nicole Nunoo successfully defended her dissertation in the Agricultural, Leadership, and Community Education PhD program in August of 2023 and is currently a Postdoctoral Research Associate addressing Human Dimensions of Climate Smart Agricultural and Food Systems at the University of Georgia. I was pleased to serve on Nicole's committee. Dr. Kim Niewolny of her department served as her advisory committee chair.
  - Dr. Molly Todd successfully defended her dissertation in the Alliance for Social, Political, Ethical, and Cultural Thought (ASPECT) PhD program in September of 2023 and is now serving as a Teaching Assistant Professor at the University of Colorado, Boulder in the International Affairs and Sociology departments. I was pleased to cochair her committee with Dr. Laura Zanotti of the Political Science Department.
- We were very pleased to host Aziz Ardic, a University of Istanbul PhD student in Philosophy, as a graduate fellow at VTIPG. Aziz was chosen by a national commission in a country-wide competition in Turkey to join us for a calendar year that began last August. Aziz worked closely with me and his advisory committee chair in Turkey as he developed his dissertation during his stay. He left us at the end of July 2024. We shall miss him very much and wish him every success.
- We also bade farewell to two of our colleagues on the FRU team in Fairfax this year.
  - Dr. Melony Price-Rhodes retired in December of 2023 following more than two decades of service with the FRU, much of that period as its Director. Melony proved an effective team leader and mentor and became an integral part of the Institute soon after we began operations. We shall miss her.

Claudia Malenich retired in June of 2024 as a Court Specialist. She
was much admired by all who worked with her for her expert
knowledge and professionalism. We know she will be gardening and
enjoying her grandchildren and we wish her much joy as she does so.

# Community & Social Change Research: The Community Change Collaborative (CCC)

- The Community Change Collaborative (CCC) hosted several faculty forums and guests this year including Professor Aaron Ansell of our Department of Religion and Culture, Solmaz Yadollahi, Research Fellow, Brandenburg University of Technology Cottbus-Senftenberg, and Dr. Ariel Otruba, Faculty Member, Arcadia University.
  - In addition to hosting thoughtful talks by these scholars and undertaking accompanying interviews for our current podcast program, the group systematized the archive of its long-standing podcast series concerning the dynamics of democratic change to enable easier public access to the collection: https://ipg.vt.edu/WhatWeDo/Podcasts.html.
- The Collaborative continues to work closely with a group called St. Paul's
  College for Life (SPC4Life) in Brunswick County, Virginia, which is
  comprised of alumni and friends of the now-closed St. Paul's College, long
  located in that community. SPC4Life is developing educational curricula for
  Brunswick County's most vulnerable young people and CCC is helping
  them with their governance strategy and strategic positioning.
- In addition, the Collaborative is working with the Calfee Community and Cultural Center (the former Calfee Training Institute) in Pulaski, Virginia, a historically Black educational institution during the period of segregation, which a community group (including alumni) is restoring for multiple uses as well as for a museum depicting the school's important history.
- I collaborated with Dr. Neda Moayerian and CCC President Brad Stephens
  to write a paper for the conference of the International Society for Third
  Sector Research in Antwerp, Belgium in July concerning this project
  entitled, "Revisiting the Social Role of Radical Imagination Amidst
  Widespread Democratic Erosion." The article is now under review at an
  academic journal.

- Finally, CCC has also collaborated on producing a new podcast series in partnership with VT Publishing and VT Libraries called Social Science for Public Good. It focuses on connecting activists, NGO leaders, and government professionals to social science theories and research that will help them to conceptualize social change more sensitively and thereby craft strategies more likely to encourage it.
  - The inaugural season of the podcast has explored current theories of trust and power across an arc of twelve episodes. Upcoming sessions will feature leading scholars on imagination and social change, democratic justice, and decolonization. Interspersing interviews with prominent theorists and explanations designed to provide context, the series seeks to communicate not only a sense of the current scholarship, but also how that knowledge is relevant to those seeking to promote social change. This project has been supported by a collaborative research grant from VT Libraries.

As I close, I would be remiss not to thank all of those who have worked with or supported the Institute this year. You are, we realize, why we exist when all is said and done. Thank you.

The Institute is working with the Roanoke City and Alleghany Health Districts (RCAHD) on a three-year process to improve the health department's community engagement strategies and data collection, and to make these strategies part of ongoing operations with the goal of continually assessing and refining service delivery.

The LAMPP program focuses on facility, office, department, or shift group training needs for front line staff and new managers, with funding from the Virginia Center for Behavioral Rehabilitation (VCBR).

The Maré Research Group is a multi-stakeholder, international research and artistic partnership. The team has been conducting ongoing research documenting the lives of residents of the Complexo da Maré in Rio de Janeiro, Brazil, through library exhibits, roundtable discussions, and written works.

The C2C project coordinates referral, treatment, recovery, and crisis response resources, including backpacks equipped with potentially lifesaving tools, to reduce overdose and substance use health issues. In 2023, the C2C team developed a Housing First Toolkit for developers and operators to increase recovery housing and harm reduction options.

### Aaron Ansell, Associate Professor, Department of Religion and Culture.

Dr. Aaron Ansell is an Associate Professor in the Department of Religion and Culture at Virginia Tech. ### Calfee Institute

Over the past year, a team of researchers from VTIPG has had the privilege of learning about the work occurring to reimagine the historic Calfee school as the Calfee Cultural & Community Center (CCCC). The Calfee Training School was originally a Black elementary and middle school in Pulaski County but has been vacant for decades. After languishing for several years, a group of Pulaski residents has recently mobilized to reimagine the physical space as well as preserve the stories of the school, which historically played a vital role in both the local Black community and the broader civil rights movement. This has led to the formation of the CCCC, with a vision for the future of Calfee including a much-needed childcare facility, community kitchen space, a community museum, outdoor play space, and more. Jill Williams, co-executive director of the effort, has met with VTIPG to share the story and discuss potential collaborative opportunities. Learn More






