Summary

My professional portfolio spans schools of medicine and public health at top tier research institutions. These institutions, each affording me unique experiences, include West Virginia University, a public land grant institution dedicated to serving the people of Appalachia, and The George Washington University, a private university one mile from the White House. In 2018 I joined Virginia Tech. Over the years, as leader and scientist, I served in the ranks of Assistant Professor, Associate Professor, and Professor with tenure, including being among the first class and first woman at WVU awarded the distinguished Robert C. Byrd named professorship. Major leadership positions have included Associate Dean of Research, Associate Cancer Center Director, Center Director, Scientific Program Leader, and Associate Vice President, many being founding positions.

Progression through an intentional research leadership trajectory provided critical experience for successfully driving changes in culture, capacity, funding, policy, and operations within complex academic health systems and in regions with the significant health disparities. Alongside my leadership roles, I remain passionate about research, serving as Principal Investigator on 50+ funded research projects, including more than two decades of continuous federal funding, and resulting in health innovations that helped thousands of teens and young adults around the world reduce and stop tobacco use. Recent novel areas of work include health behavior technology, harm reduction, and opioid use disorder prevention. Central to my work as both scientist and leader is the translation of research to impact the urgent health matters of communities, families, and individuals. Impact is the bottom line, best achieved through evidence, diverse and innovative partnerships, and policy and sustainable practice improvements. Along my journey, I have had the privilege of mentoring dozens of students, and of working alongside hundreds of faculty, staff, clinicians, and community members, all enriching my life in immeasurable ways. I stay on this journey because I believe that research across public, private, and community sectors is key to revolutionizing societal health and well-being.
