Our democracy's greatest threat isn't Trump-it's the Electoral College

Columnists Paul Goldman and Mark Rozell argue for the abolition of the Electoral College in this essay. They assert that former President Donald Trump's path to victory in 2024 rests in winning via the Electoral College and not in the popular vote. Ron DeSantis's plan to strip First Amendment rights from the press, explained

In this article, Ian Millhiser describes Florida Governor Ron DeSantis's plans to weaken First Amendment protections for the press. Those include advocating for repeal of the Supreme Court's *New York Times v. Sullivan* (1964) decision, which established that the government and, in many instances, private litigants may not seek to censor the media, political advocates, and the general public through defamation suits aimed at silencing opposing views. Republicans in the Florida legislature have already introduced bills that attack this precedent, which Millhiser argues is the foundation of free speech in America. Millhiser notes that a DeSantis presidential win in 2024 could lead to his selection of federal judges who support overturning this principle.
